

# 0% INTEREST NEW SMALL BUSINESS LOAN FOR FEMALE VETERANS (AND FEMALE SPOUSES OF VETERANS)

## PARTICIPANT GUIDELINES

- \$ MUST HAVE A PERSONAL INCOME LESS THAN 350% OF POVERTY LEVEL. (SEE OTHER SIDE)
- \$ MUST ATTEND THE *START RIGHT!* SEMINAR OR 5 HOURS BUSINESS CONSULTING ON BUSINESS PLANS PRIOR TO APPLYING — NO CHARGE
- \$ MUST PREPARE BUSINESS PLAN — PER ABOVE CLASSES
- \$ PARTICIPANTS MUST HAVE LITTLE OR NO PRIOR BUSINESS EXPERIENCE
- \$ NEW BUSINESS MUST BE INDEPENDENTLY OWNED AND OPERATED BY A WOMAN OR WOMEN IN THE STATE OF NEW JERSEY
- \$ APPLICANT MUST BE A FEMALE VETERAN OR THE FEMALE SPOUSE OF A VETERAN.

## LOAN GUIDELINES

- \$ FUNDS MAY BE USED FOR WORKING CAPITAL, INVENTORY, SUPPLIES, FURNITURE, MACHINERY, EQUIPMENT AND FIXTURES FOR A NEW BUSINESS.
- \$ \$5,000.00 MAXIMUM LOAN
- \$ INTEREST AT 0%
- \$ UP TO 5 YEARS FOR LOAN REPAYMENT
- \$ APPLICATION FEE OF \$50.00 — NON-REFUNDABLE
- \$ MUST ATTEND ADDITIONAL REQUIRED ENTREPRENEURIAL TRAINING CLASSES OR INDIVIDUAL COUNSELING AFTER RECEIVING LOAN — NO CHARGE
