Loan Package Requirements

- The business **MUST** be located in Mercer County
- Completed & signed application along with a \$100 application fee
- Three years of personal tax returns and W2s
- Three years of business tax returns (if already in business)
- Business plan for all start-ups
- Financial projections
- Copy of draft lease (if applicable)
- Evidence of owner's contribution to the project
- Copy of operating agreement for all corporations and LLC/Ps
- Evidence that the business is current on all state, payroll and sales taxes
