Approving the Redirection of Projects Funded from the 1999 A Bond and  
the 2002 D Bond**

**WHEREAS:** The College of New Jersey Board of Trustees at its June 21, 2001 meeting approved the Conceptual Campus Facilities Master Plan Framework; and

**WHEREAS:** The 1999A and 2002 D College Bond Issues funded portions of the plan; and

**WHEREAS:** Included in this plan are funds designated for the renovation and expansion of the Travers Wolfe Residence facility for freshmen housing; and

**WHEREAS:** As part of a consultative process, The College has determined that it would be advantageous to move the freshmen housing to the proposed Lakeside Complex;

**Therefore Be It Resolved:**

That funds from the 1999A and 2002 D Bonds, originally dedicated to the renovation of Travers Wolfe, be redirected to Phase I of the Lakeside Housing Complex except for those planning funds already expended for the renovation of Travers Wolfe Hall.
